DECIDES:

Article 1: A competitive entrance examination for admission in to the first year of the Master's cycle in Clinical Biology, Radiology and Medical Imaging, Operating Theater Assistant, Public Health and ENT Assistant, in the Department of Biomedical and Medico-sanitary Sciences of the Faculty of Sciences (FS) of the University of Ebolowa is open on the 26th of October 2025 for the 2025-2026 academic year.

The candidates will write in the centers of Ebolowa, Yaoundé and Douala.

Article 2: The places offered are distributed as follows:

Article 3:

- (1) The competitive entrance examination is opened for a single session to Cameroonians of both genders, holders of a bachelor's degree in Biomedical or Medico-sanitary Sciences, or any other equivalent certificate recognized by the Minister of State, Minister of Higher Education.
- (2) Candidates from Member countries of the Economic and Monetary Community of Central Africa (CEMAC) who have ratified the texts concerning the national treatment of students will also be admitted under the same conditions as Cameroonian students.
- (3) Candidates from non CEMAC countries just like members from CEMAC countries who do not want to write the competitive entrance examination could be admitted after a study of their files, depending on the availability of places, if they are beneficiaries of scholarships from their governments or an international organization, committed to pay the higher education tuition as stipulated by the law.

Article 4: The complete application files must be submitted at the Admission and Records Office of the Faculty of Science, University of Ebolowa, the Admission and Records Office of the Faculty of Science, University of Douala, in MINESUP (Room 929) not later than October 24, 2025, and shall comprise the following documents:

- 1- A stamped handwritten application at the standard rate
- 2- A registration form available on the Admission and Records Office of the Faculty of Science of the University of Ebolowa, the Admission and Records Office of the Faculty of Science of the University of Douala, or in MINESUP (Room 929).
- 3- A certified photocopy of birth certificate not more than 3 months old;
- 4- Certified photocopies of Bachelor's Degree transcripts or any certified proof of success in any of these examinations;
- 5- The first, second- and third-year transcripts signed or certified by competent authorities.
- 6- A medical report attesting that the candidate is apt for higher education studies, issued by a physician of the public administration.
- 7- Five passport-size photographs 4x4, with the names of the candidate at the back.
- 8- A receipt of payment of entrance examination fee fixed at the sum of 20.000 (twenty thousand) CFA Francs at "Société Générale du Cameroun" to account n° 10003 03400 22341303796 56 FS Ebolowa;
- 9- A duly stamped A4 envelop with the personal information (address) of the candidate.

NB: Candidates who have submitted their files pending the completion of their Bachelor's Degree will only be admitted and/or authorized to register after presentation of proof of their admission into the said certificate (signed past result slips, transcripts, etc.).

Article 5: Candidates with foreign diplomas must produce either the Equivalence Order or the receipt of submission for the application of equivalence of their diplomas issued by the Ministry of Higher Education. However, their final admission and the delivery of the diploma or certificate of success at the end of their training can only be acquired upon presentation within the deadlines set by the competent

authority, of the text granting equivalence to their diploma, and obtained from the Ministry of Higher Education by the candidate.

Article 6: The registration fee is non-refundable.

Article 71 Only candidates with complete application files would be allowed to compete for admission into the study programs

Article 8: The competitive examination is made up of:

- (2) The general knowledge test deals with the current developments and history of medicine.
- (3) The program of the specialty course of the Master cycle is that of bachelor's degree program;
- (4) The study of the file (coefficient 1) is established according to the university's curriculum of the candidate

Article 9: (1) The deliberations are carried out by a jury appointed by the Minister of State, Minister of Higher Education following the proposition of the Rector of the University of Ebolowa.

(2) The final results are published through a press release by the Minister of State, Minister of Higher Education.

Article 10: The admission cannot be postponed from one year to another.

Article 11: The expenditures linked to the organization of the competitive entrance examination are imputable to the 2025 budget year of the Faculty of Science of the University of Ebolowa.

Article 12: The Rector of the University of Ebolowa, the Director of University Accreditation and Quality and the Dean of the Faculty of Science of the University of Ebolowa are responsible, each in his/her sphere of competence, for the implementation of this decision, which will be registered and published wherever necessary.
