



DÉCISION N° **18250474** MINESUP/SG/DAUQ/SDEAC OF **22 JUL 2025**

To Launch a competitive entrance examination into the first year of undergraduate studies in the Biomedical and Medico-Sanitary Sciences in the Faculty of Sciences (FS) in the University of Ebolowa, and the cycle of Bachelor Engineering in the « Higher School of Computer and Technologies Studies » HISCOTS in Yaoundé, for 2025/2026 academic year.

Mindful of decision No. 19250145 /MINESUP/SG/DAUQ/SDEAC of 07th April to organize the calendar of competitive examinations into Faculties, Schools and Institutes of State Universities for the 2025/2026 academic year;

DECIDES:

Article 1: A competitive entrance examination is open on the 26th of October 2025 for the 2025-2026 academic year for the admission of 1050 students, which is distributed as follows:

- 1) 200 students into the First Year of the undergraduate programs in the field of Biomedical and Medico-Sanitary Sciences of the Faculty of Science (FS) of the University of Ebolowa
- 2) 850 students into the First Year of the cycle of Bachelor of Engineering in the following fields: Robotics, Computer Science and Digitalization, Virtual Reality and Augmented Reality, Data Science, Computer Security ; Computer Engineering, Software Engineering, Information and Communication for Development of the Higher School of Computer and Technologies Studies - HISCOTS de Yaoundé, Private Higher Education Institute, authorized to offer training under the academic mentorship of the Faculty of Sciences (FS) of the University of Ebolowa.
- 3) The candidates will write in the centers of: Ebolowa, Yaoundé and Douala for the field of Biomedical and Medico-sanitary Sciences and those of HISCOTS in the centres of: Ebolowa, Yaoundé, Douala and Bafoussam.

The candidates for the competitive entrance examination in to the first year must be 25 years old at most by 1st of January 2026.

Article 2 :

- 1) Concerning the field of Biomedical and Medico-Sanitary Sciences, the competitive entrance examination is open in one session to Cameroonians of both genders, holders of a Baccalaureate C, D and F7, F8, or the General Certificate of Education Advanced Level (GCE "A" Level) in at least three science subjects or any other equivalent certificate recognized by the Ministry of Higher Education.
- 2) Concerning the programs offered by the Higher School of Computer and Technologies Studies – HISCOTS, the competitive entrance examination in the fields of Robotics, Computer Science and Digitalization, Data Science, Computer Security ; Computer Engineering, Software Engineering, Information and Communication for Development is open in one session to Cameroonians of both genders, holders of a Baccalaureate series C, D, TIC, F1, F2, F3, F5 or the General Certificate of Education Advanced Level (GCE "A" Level) in at least three science subjects or any other equivalent certificate recognized by the Ministry of Higher Education.
- 3) The competitive entrance examination in the field, Virtual Reality and Augmented Reality, is open in one session to Cameroonians of both genders, holders of a Baccalaureate or the General Certificate of Education Advanced Level (GCE "A" Level) or any other equivalent certificate recognized by the Ministry of Higher Education. *W*

- 4) Candidates from member countries of the Economic and Monetary Community of Central Africa (CEMAC) who have ratified the text concerning the national treatment of students and with proof of the required qualifications are admitted to write under the same conditions like those of Cameroonian origin.
- 5) Candidates from non CEMAC countries just like candidates from CEMAC countries who do not want to write the competitive entrance examination could be admitted after a study of their files, depending on the availability of places, if they are beneficiaries of scholarships from their governments or an international organization, committed to pay the higher education tuition as stipulated by the law.

Article 3 : The complete application files for candidates in the field of **Biomedical and Medico-Sanitary sciences** and the « **Higher School of Computer and Technologies Studies-HISCOTS** » must be submitted at the Admission and Records Office of the Faculty of Science, University of Ebolowa, at the Ministry of Higher Education, 9th floor, room 929 in Yaoundé, the Admission and Records Office of the Faculty of Science, University of Douala in Douala, not later than the 24th of October 2025.

For the field of Biomedical and Medico-Sanitary Sciences, it shall comprise the following documents:

- 1- A Registration Form available on, the Admission and Records Office of the Faculty of Science of the university of Ebolowa, , at the Ministry of Higher Education, 9th floor, room 929 in Yaoundé, the Admission and Records Office of the Faculty of Science of the University of Douala.
- 2- A Receipt of payment of entrance examination fee fixed at the sum of 20.000 (twenty thousand) CFA Francs at "Société Générale du Cameroun" bank, to the account n° 10003 03400 22341303796 56 FS Ebolowa
- 3- A Certified photocopy of Baccalauréat or GCE 'A' level or any certified proof of success attestation in any of these examinations;
- 4- Certified photocopies of Baccalauréat transcripts and Probatoire or a certified copy of proof of success at the GCE A/Level and GCE O/Level ;
- 5- A certified photocopy of birth certificate not more than 3 months old.
- 6- A Medical Certificate attesting that the candidate is apt for Higher Education studies, issued by a physician of the Public administration;
- 7- Five passport-size photographs 4x4, with the names of the candidate written at the back;
- 8- A duly stamped A4 envelop with the personal information (address) of the candidate.

For the programs offered by the **Higher School of Computer and Technologies Studies - HISCOTS de Yaoundé**, it shall comprise the following documents:

- 1- A registration form available on the MINESUP website: www.minesup.gov.cm, or the website of HISCOTS : www.hiscots.cm/fiche-concours;
- 2- The transaction code *126*4*20000# in the account of HISCOTS attesting the payment by MTN Mobile Money of the fees of the entrance examination at an amount of 20 000 FCFA;
- 3- Certified photocopies of Baccalauréat transcripts and Probatoire or a certified copy of proof of success at the GCE A/Level and GCE O/Level;
- 4- A certified photocopy of birth certificate not more than 3 months old.
- 5- A medical certificate attesting that the candidate is apt for Higher Education studies, issued by a physician of the Public administration.

NB: *Candidates who have submitted their files pending the baccalaureat or GCE A level will only be admitted and/or authorized to register after presentation of proof of their admission into the said diploma (signed success result slips, transcripts, etc.).*

Article 4: The registration fees are nonrefundable.

Article 5: Only candidates with complete application files will be allowed to compete for admission into the programs.

Article 6:

1) For the field of Biomedical and Medico-sanitary Sciences

a) The competitive entrance examination is made up of:

- Evaluation of academic profile (coefficient 2, thus, 30% of the total mark)
- written examination (coefficient 5, thus 70% of the total mark)

b) The evaluation of academic profile (coefficient 2) is based on:

- age of candidate
- results of the GCE 'O' Level or *Probatoire*;
- results of the GCE 'A' Level or *Baccalauréat*;
- the number of times one repeats a class or the public examination.

c) The competitive examination is made up of the following subjects:

2) For the programs of the Higher School of Computer and Technologies Studies - HISCOTS of Yaoundé,

a) The competitive examination is made up of the following subjects:

- Evaluation of academic profile (coefficient 2, thus, 30% of the total mark)
- written examination (coefficient 5, thus 70% of the total mark)

b) The evaluation of academic profile (coefficient 2) is based on:

- results of the GCE 'O' Level or *Probatoire*;
- results of the GCE 'A' Level or *Baccalauréat*;
- the number of times one repeats a class or the public examination.

c) The written subjects are made up of the following:

Article 7: Each subject is scored from zero to one hundred. Any score less than twenty in any written test disqualifies the candidate.

Article 8 :

1) The program of the Entrance examination for the field of Biomedical and Medico-sanitary Sciences is that of Scientific Baccalauréat C and D or of GCE « A » Level in the following subjects : Biology, Chemistry, Physics.

- 2) The program of the Entrance examination for programs of the Higher School of Computer and Technologies Studies – HISCOTS is that of Scientific Baccalauréat C, D, TI or of GCE « A » Level in all the science subjects, with the exception of the field Virtual reality and Augmented Reality, therefore the program is common to all Baccalauréat and GCE A Level of Cameroon.

Article 9:

- 1) Deliberations are done by a jury appointed by the Minister of State, Minister of Higher Education following the proposition of the Rector of the University of Ebolowa.
- 2) The results are published through a press release by the Minister of State, Minister of Higher Education.

Article 10: The admission cannot be postponed from one year to another.

Article 11: The expenditures linked to the organization of the competitive examination are imputable to the 2025 budget year of the Faculty of Science of the University of Ebolowa.

Article 12: The Rector of the University of Ebolowa, the Director of University Accreditation and Quality and the Dean of the Faculty of Science of the University of Ebolowa are responsible, each in his/her sphere of competence, for the implementation of this Decision which will be registered and published wherever necessary.
